Thank you all for your quick survey responses. As you know, CWDGA is striving to assure that our tournaments are run in a safe and healthy environment in accordance with the Illinois Phase IV Golf Guidelines. Due to the Guidelines many significant changes to our events must take place. It is because of these changes that we surveyed all of you to gauge your continued interest in playing in the One-Day Stroke Play tournament.

Unfortunately, the survey indicated that there was considerable concern from players to participate in this event. This concern reduced our field measurably, so much that it did not warrant going forward with the tournament. **Therefore, we are cancelling the One-Day Stroke Play tournament this year.** North Shore Country Club has graciously offered to host the One-Day Stroke Play in 2021, and we will be working on a mutually agreeable date with them.

We know that many of you will be disappointed in CWDGA's decision to cancel this event as there was a core of interested participants. We, at CWDGA, are disappointed also. This season has been very disruptive for all of us. We can only hope that next year will provide a more normal environment.

Since you have already paid your entry fee via a credit card, you will receive a **full** credit to that card. That is, there will be no transaction fee applied.
